The CE having CE License issued from the undersigned can apply for PCPNDT to the undersigned.

In reference with the Clause (b), Sub Rule 1, Rule 5 of The Pre-Conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Rules, 1996 as amended vide GSR 80(E) dt.07/02/2012, w.e.f. 29/02/2012, the application fees once paid will not be refunded, also not transferrable. For any application rejected and again re-submitted within 90 days of application, no fees will be needed. Thus, for erroneous application, the application will be rejected and fees will not be refunded.
