Deposition of earnest money:

- a) Net banking (any of the banks listed in the ICICI Bank gateway) in case of payment through ICICI ban Payment Gateway.
- b) RTGS/NEFT in case of offline payment through bank account in any bank.

6.1 Payment by Net Banking:

- a) On selection of net banking as payment mode, the bidder will be directed to ICICI Bank Payment Gatewa webpage (along with a string containing a UNIQUE ID) where he will select the bank through which he/ she wan to do the transaction.

6.2 Payment through RTGS/ NEFT:

7. Technical Evaluation

The committee ("Evaluation Committee") appointed by the Procurement Entity will carry out the evaluation Proposals based on the eligibility criteria. If required, the Procurement Entity may seek specific clarifications fr any or all Bidder (s) at this stage.

8 Financial Evaluation:

- a. The financial bid shall be opened of only those bidders who have been found to be technically eligible. The financial bids shall be opened in presence of representatives of technically eligible bidders, who may like to be present.
- b. The Financial Bids of unsuccessful bidders would not be opened and will be rejected.
- c. The rates must be quoted per BOQ.
- d. If there is a discrepancy between words and figures, the lesser amount shall be considered as valid. If th Supplier does not accept the correction of the errors, his bid shall be rejected.
- e. The Tender Selection Committee does not bind himself to accept the lowest bid or any bid and reserves the right of accepting the whole or any part of the bid or portion of the job offered; and the bidder shall provide the same at the rates quoted. The Tender Selection Committee reserves the right to reject any or all offer received in response to tender or cancel or withdraw the tender notice without assigning any reason whatsoever.

9. Procurement Entity's Right to Accept Any Proposal, and to reject any or All Proposals

The Procurement Entity reserves the right to accept or reject any Proposal, and to cancel / annul the bidding process and reject all Proposals at any time prior to contract award, without thereby incurring any liability the Proposers for which the Procurement Entity shall keep record of clear and logical reasons properly for an such action / recall of bidding process. In case of cancellation / annulment, all Proposals submitted an specifically, EMD shall be promptly returned to the Proposers.

10. Refund / Settlement Process:

- a) After opening of the bids and technical evaluation of the same by the tender inviting authority (TIA) throu electronic processing in the e-Procurement portal of the State Government, the TIA will declare the status the bids as successful or unsuccessful which will be made available, along with the details of 1 unsuccessful bidders, to ICICI Bank by the e-Procurement portal through web service.
- b) On receipt of the information through e-Procurement portal, the Bank will refund, through an automar process, the EMD of the bidders disqualified at the technical evaluation to the respective bidder's be account from which transaction was made. Such refund will take place within T+2 Bank Working D: (Where T means the date on which information on rejection of bid is uploaded to e-Portal by the TIA.)
- c) Once the Financial bid evaluation is electronically processed in the e-Procurement Portal, EMD of technically qualified bidders other than that of L1 & L2 bidders will be refunded, through an automa process, to the respective bidders' bank account from which payment was made. 10. Performance Security

11. Terms & Conditions:
