- ii. Valid Trade License / Certificate of Enlistment.
- iii. GST Registration Certificate with latest return.
- iv. Professional Tax Registration Certificate along with up-to-date challan.
- v. Photocopy of the first page of passbook where name of the bidder & the Account number, IFSC Code, etc is mentioned.
- vi. IT Return for the last 01 (one) financial years i.e 2023-24.
- vii. Credential of the participant for similar nature of work in past.

The Quotation Inviting Authority reserves the right to accept or reject any quotation, as a whole or part thereof, at any point of time without assigning the reason(s) whatsoever. Physical Verification of post-calibration items may be done at the discretion of the authority to adjudge the applicability or suitability of the service. The bidder should be competent enough to service / adjust micropipettes, if deviation found & ensure handover of all equipments back to authority in functional status after calibration done, otherwise payment may be withheld.

The work shall be carried out at Chandidaulatabad BPHC, Bishnupur-I Block & must be completed within 07 (Seven) days from issuance of award of contract, including onsite technical demonstration. The bill amount may be paid only after delivery of Calibration Certificate for equipments of respective health facilities under Bishnupur – I, Block, South 24 Parganas and after availability of allotment in terms of Memo No. HFW-45035(99)/81/2021-CMOH(HFW)-Dept. of H&FW/3249 Dated 27.11.2024.

Price which is a relevant factor may not be the only criteria for acceptance of lowest bid for any or all items. The other criterions must also be kept into consideration like

- ii. Competency of the bidder to accomplish the work within the specified time schedule.
