
The quotations will be received on and from 17.05.2017 to 25.05.2017, except Govt. holidays in between 10 a.m.- 4 p.m. in drop box or it may also be submitted either through speed post which must reach this office within 1 p.m. of 25.05.2017. The quotations will be opened at 1 p.m. on the same day (25.05.2017). Applications in due format will be received from bidders addressing the “**Superintendent, Vidyasagar State General Hospital, South 24 Parganas**” and the quotation no. and date must be mentioned in the application.

Terms and conditions:-

1. Name, Address and Quotation No and purpose must be clearly mentioned on the sealed envelope.
2. Quotations has to submit the sealed envelope form at their own cost to the office of the undersigned within stipulated time through speed post only and will be opened by the purchase committee in presence of the bidder or his representative.
3. The claimed rate should cover transport and delivery charges. The tender must indicate whether the price quoted is inclusive of VAT, Sales Tax or not. Quoted rates should be clearly mentioned in both figures and words.
4. Cooperative society should furnish along with their tender current certificate from ARCS of concerned district regarding performance.
5. All sheets should be numbered properly and number of sheets in each cover should be cited in covering tally.
6. Pan No., Trade License is to be furnished with the tender documents.
7. The rate per piece of the window curtain (cotton cloth of good quality) and door curtain completed with steel rod and fittings (with sample to be demonstrated at the time of opening of quotation in front of the purchase Committee) to be quoted which must be inclusive of labour and fitting charges (if not so please mention otherwise).
8. Please refer to website www.spghealth.gov.in or notice board of this hospital for further corrigendum (if any) during the period of processing.

In case of necessity, the date of opening may be deferred, in that case notification will be displayed in the Notice Board in the Office of the undersigned in due time.
