Item III: Half Body (Upper) Central Venous Catheterization Model

Material: Polyurethane (Stain, Stress, torsion proof).

Weight: <20 kg

Specifications:

- Cervical Anatomical Landmarks must be very clearly visible, like sternal notch, clavicle sternocleidomastoid muscle etc
- 2. Venous vascular system must be in proper anatomical position, like, common carotid artery internal jugular vein, external jugular vein, subclavian vein, bracheocephalic vein
- 3. Puncture of vein should be felt like apparent "pop" as in human body
- 4. Artery should be able to make pulsatile during procedure
- 5. Vascular puncture should be denoted by withdrawal of blood
