- Onsite Delivery with Screening and one follow up at different schools and supply of power glass of different size as requisitioned by the ophthalmologist /MT(Opt.)/PMOA at Bhangore-I Block South 24 Parganas district under NPCB & VI Programme.
- The period of tender will be initially for three years from issue of offer letter subject to yearly renewal on satisfactory performance.
