- 3) The Spectacles are to be provided free of cost to school children & old person referred by OptometristAssistant. the supplier shall have to deliver spectacles to the Ophthalmologist /MT(Opt.)/PMOA Baruipur SD &SSH on the basis of requisition placed.
- 4) The supplier would submit the required documents at the end of each month for the payments to be made by the Rogi Kalyan Samiti Baruipur SD SSH and payment would be made within 30 days ofreceiptso1"bills.

5. TERMS OF SUPPLY& PAYMENT: -

- a. The payment will be made within 30 days of the receiptof the itemsand alter completion of all formalities. Noadvance payment will be made.
- b. The firm will be bound to supply the items within stipulated period, failing which action will be taken todebar the firm from taking part in future purchases of Secretary Rogi Kalyan Samiti & Superintendent, and proceedings will be constituted against the firm to blacklist them.
