The District Health & Family Welfare Samity, South 24 Parganas, is inviting "Expression of interest" from reputed Voluntary Organization (V.O) / Non – Government Organization (NGO) for the scheme of NGO Scheme under "National Programme for Control of Blindness (NPCB)" in South 24 Parganas for two year (F.Y – 2021 – 2023)

The V.O/NGO Should have following eligibility criteria:

- Registered under the Indian Societies Registration Act. 1860 (Act. XXI of 1860 or any such act resolved by the State a charitable public trust registered under any law for the time being in force.
- 2. All V.O/NGO must have Currently Valid Society Registration Certificate.
- 3. Having well trained staff, infrastructure and the required managerial expertise to organize and carry out various activities under the scheme; and having own base hospital as requisite of National Programme for Control Blindness (NPCB) located within the district of South 24 Parganas.
- 4. The base Hospital must have Currently Valid Clinical Establishment License.
- All V.O/NGO must Register themselves with NGO DARPAN PORTAL (NGO Partnership System applying at the time of MOU. Payment will be must be made to V.O/NGO registered in NGO DARPAN PORTAL only.
- Track record of having experience in providing health service preferably eye care services over a period of three year.
- 7. Properly constituted managing body with its powers duties and responsibilities clearly defined and laid down in a written constitution.
- 8. Other Conditions as laid down in the guidelines of NPCB will have to be adhered by the V.O/NGO otherwise, the MOU may be ineffective.

The interested VO/NGO are requested to submit their EOI along with self-attested hard copies (Photocopies) of all the relevant documents in Docket Section of the Chief Medical Officer of Health, South 24 Parganas, Public Health Wing, M.R.Bangur Hospital Complex, 241, Deshpran Sashmal Road, Kolkata – 700033. Last Date of receipt of application is 10th July – 2021 till 5 PM mere submission of application does not guarantee inclusion for MOU with the District Health & Family Welfare Samity. Decision of the Health & Family Welfare Samity will be final. After selection, the V.Os/NGOs will undergo signing of MOU and MIS training and they have to abide by NPCB Guidelines throughout the period.
