1. Chief Medical Officer of Health & Secretary **District Health & Family Welfare Samity, South 24 Parganas** at M.R Bangur Hospital, 2nd floor, Kolkata-33, South 24 Parganas, invites e-tender from the intending experienced bonafide eligible resourceful outsiders and working contractors/agencies having experience in relevant nature and magnitude of the constructional work mentioned as noted in ANNEXURE-I(Enclosed).
2. The accepting authority does not bind him –self to accept the lowest bidder and reserves the right to reject any or all of tenders received, without assigning any reasons. He further reserves the right of splitting up any contract and distributing the same to more than one bidder.
 - a. **This is an e-procurement tender and also a two bid tender. First bid should contain document of earnest money & technical documents (i.e. trade license, pan card, credential etc.)and second bid should contain the financial offer to be submitted online.**
3. **Contractors /agencies are requested to observe the required credential. If any agency found submitted bid for the specific serial with below credential or false credential or any false paper the earnest money will be forfeited.**
4. The intending bidders should submit tenders within specified time along with **scanned copies of original documents (scan of Xerox copy of any documents is not allowed) –**
 - a. **Trade License (Civil)** (valid for current period 2022-2023),
 - b. **Trade License (Electrical)** (valid for current period 2022-2023),
 - c. **G.S.T** Registration No. With current return. 2021-22
 - d. **Professional Tax** Enrolment Certificate with current year payment challan/return,
 - e. **Pan Card.**
 - f. **I.T Return** for Financial years ,2019-20,2020-21,2021-22
 - g. Agreement with Civil & Electrical Engineer & **Agency/Firm/ Company** having Civil & Electrical **Trade License** or(In case of Electrical) **Electrical** supervisory License or License holder Supervisor must submit Electrical License with last renewal for execution of Electrical works. If the bidder is not an Electrical license holder, he/she should submit Agreement paper executed in between the bidder & license holder and such Agreement should be at least be in the form of **1ST class Judicial Magistrate.**
 - h. **Credentials:** Completion/ payment certificate with relevant work order of Govt. offices/ Govt. undertakings/ local bodies of **similar nature of job** as noted in annexure-I (enclosed) Credentials under sub-contract is not valid. The intending bidder should produce credential of similar nature of structural works of a completed single work having minimum value of 40% (Forty per cent) of the estimated amount put to tender during 03 (three) years prior to the date of the issue of the e-Tender notice.
 - i. **One bidder can apply for more than one bid subject to his credential being calculated on the sum total of all credentials of work done during 3(three) years prior to the date of issue of e-Tender.**
 - j. The Contractors /Agencies shall provide Engineers (Civil & Electrical) at least diploma holder for visit the site /office as per the instruction of the Engineering wings, NHM(DPMU)South 24 PGS as when as necessary for the said work.
 - k. **In case of a partnership firm; it must be registered under any law.**
 - l. **In case of a partnership firm/ co-operative institution there should be clearly mentioned the authorized person who carry on the business in favor of the institution in form of deed/agreement / resolution if applicable.**

5. **State Team & district team will make periodical onsite visit to review the progress of the work and check the quality of work being implemented.**
6. The intending bidders shall have to furnish original certificates of all documents with execution of similar works of requisite magnitude as and when demanded by the tendering authority.

10. The bidder should quote his /their rates in figures and words on the basis of percentage above, below or at par with the schedule of rates attached with the tender form online.

11. **A) As per Govt. Order No. 4608 - F(Y) Dated 18/07/18, to ensure the quality and prior execution of the work in public interest, the Governor is pleased to decide that Additional Performance Security @10% of the tendered amount shall be obtained from the successful bidder if the accepted bid value is 80% or less of the estimate put to tender.**

B) The additional Performance Security shall be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his earnest money will be forfeited and other necessary actions as per NIT like blacklisting of the contractor, etc. may be taken. The Bank Guarantee shall have to be valid up to end of the Contract Period and shall be renewed accordingly, if required.

C) The Bank Guarantee shall be returned immediately on successful completion of the Contract. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor. Necessary provisions regarding deduction of security deposit from the progressive bills of the contractor as per relevant clauses of the contract shall in no way be altered/ affected by provision of this Additional Performance Security.


12. **A) Cost of tender paper:** Not required.

B) Earnest money: Earnest money [as indicated in the corresponding column of the work in the annexed sheet that 2% of A.P.T (in Rs.) should be deposited by the bidder [except Micro and Small Enterprise (MSEs) as defined in MSE Procurement policy issued by

Department of Micro, Small and Medium Enterprise (MSME)] through e-procurement portal as per Memorandum, memo. 3975-F(Y), dtd. - 28. 07.2016.

C) Performance Security will be deposited/deducted from bill at the prevailed rate as per the order of the Finance Department, Govt. of West Bengal vide its Memo No. 201-F(Y) dated 18.01.2021.

13. The successful bidder/s should execute an agreement with **District Health & Family Welfare Samity, South 24 Parganas** within ten days from the date of acceptance of the tender, failing which the tender be liable to be rejected.
14. Bidder /s shall be bound to execute any excess and supplementary works as may be ordered by the TIA at the rate of prevailing schedule of PWD/PW(R) D, GOVT. OF W.B at the time of tender submission.
15. Due to work at Hospital the Contractors/Agencies will be responsible for work at emergency basis and urgently finishing the work
16. All tools and plants and implements required for the construction of the work, will have to be supplied by the contractor at his/their own cost.
17. The applications of the bidder, who could not complete the works entrusted to them in past to the full satisfaction of this **District Health & Family Welfare Samity , South 24 Parganas** , will not be considered.
18. Security Deposit, Labour Welfare Cess, T.D.S on Income Tax and G.S.T. will be deducted from the bills as per Govt. Rules. EMD/ Security Deposit will be released as per Govt. rules (vide memo.- 5696-F(Y), dtd.-01st October 2019 read with Memorandum Vide memo No. - 201- F(Y), dtd.- 18.01.2021).


