

NOTICE INVITING APPLICATIONS FOR ESTABLISHING DIAGNOSTIC FACILITIES IN BLOCK PRIMARY HEALTH CENTRES & RURAL HOSPITALS UNDER PUBLIC PRIVATE PARTNERSHIP.

Government of west bengal intends to establish Diagnostic Facilities under Public Private Partnerships in the selected Rural Hospitals & Block Primary Health Centres in the District of South 24 Parganas as per list (Annexure I) of this notice. Applications in the prescribed format are invited from eligible & reputed diagnostic laboratories to establish the diagnostic facilities in such selected Rural Hospitals & Block Primary Health Centres in terms of the **scheme of Establishing Diagnostic Service in Block Primary Health Centres / Rural Hospitals through Public Private Partnerships** [Published in January 2010 ] which is annexed along with (Annex-II).


The Applicants are required to note the following:

1. The Eligibility Criteria of the applicant is available in schedule VII of the above mentioned scheme. Applicants fulfilling the eligibility criteria should only apply.
2. The application is to be submitted in the prescribed format as given in schedule VIII of the scheme along with the requisite documents as indicated therein.
3. The Diagnostic unit will be required to mandatory Diagnostic Services as per Schedule A of the scheme.
4. The diagnostic unit to set up under the scheme is allowed to realize the cost of diagnostic services as per rates fixed by health & Family Welfare Department in schedule VI of the scheme.
5. Application in prescribed format are to accompanied by an application money of Rs. 5000/- for each facility / unit to be payable in Demand Draft to be drawn in favour of "South 24 Parganas District Health & Family Welfare Samiti" payable at Kolkata. Application money of the unsuccessful applicants will be refunded.
6. Applicant willing to submit application for more than one facility is required to submit the same for each facility separately along with application money.
7. Application is to be submitted to The Chief Medical Officer of Health & Member of Secretary, District Health & Family Welfare Samiti, South 24 Parganas.
8. Last date of submitting application is July 11, 2014 with in 3 pm.
9. Other terms and conditions are clearly indicated in the scheme of Establishing Diagnostic Services in Block Primary Health Centres / Rural Hospitals through Public Private Partnerships.
10. After receipt of the applications on July 11, 2014, The District Health & Family Welfare Samiti will open the application on the same date at 3:30 pm in presence of the applicants who are willing to be presence.
11. A selection committee constituted by the respective District Health & Family Welfare Samity will evaluate the applications strictly in terms of the selection criteria specified in shedule VII of the scheme. The Committee has exclusive ight to accept or reject any or all applicant without assigning any reason thereof.
