Complaints against Partha Ghosh BAM, Bethuadahari RH, Nadia [HFW-27099/74/2024-NHM Sec Dept of H&FW]	 1.1: In the 23rd HRAC meeting it was decided that: CMOH, Nadia will conduct an enquiry with district level officials and send a detailed report with specific comments and recommendations to this end. 1.2: The Enquiry Committee under CMOH Nadia, concluded that: As per the inspection of all the records it seems that there are some gross financial irregularities regarding condemnation, Auction procedure, Tree Cutting, Nischoy Yan Vehicles and Pond digging matter. That Govt. assets and earnings are not accounted for nor deposited to the Treasury 1.3: However, the Enquiry Committee has not mentioned anything specifically in the Enquiry report regarding the allegation against Shri. Partha Ghosh, BAM of Bethuadahari RH Nadia or any other person responsible for such gross financial irregularities. 1.4: CMOH, Nadia is now being directed to communicate his opinion regarding the observations related to irregularities pointed out by the Enquiry Committee along with recommendations/action points within 15 days of receipt of this communication.

Two Months Leave without pay of Medical Ground of Kamala Mandal, CHA, Anchuri RH, Bankura [HFW-27011/103/2024-BANKURA CMOH SEC-Dept. of H&FW]	2.1: In the 23rd HRAC meeting it was decided that: CMOH, Member Secretary, District H&FW Samiti, Bankura will issue a letter with receipt instructing Kamala Mandal, CHA, Anchuri RH, to join at her respective place of posting within seven (7) days from the receipt of the notice along with all medical reports, barring which decision of non-renewal of contract beyond 30-06-2024 may be considered. 2.2: Based on the same a letter vide Memo No.2796 was issued on 21.06.2024 through Speed Post and email was sent to Mrs. Kamala Mandal, Community Health Assistant (CHA), Bhagabanpur Sub-Health Centre (SSK) under Anchuri Rural Hospital (RH), regarding instructions for joining. 2.3: However, since she has not joined till date notice may be served to her once again with instruction to join at her respective place of posting within seven (7) days from the receipt of the notice barring which the employee's contractual engagement stands terminated under Clause 11 of Order issued vide Memo No. SHFWS/ESTD/-578/2012/1135 dated 16/10/2023. 2.4: In case of non-joining, CMOH and Member Secretary, DH&FWS Bankura is directed complete the process of deletion in HRMIS.

Clarification re-joining of NHM employee - Priyanka Saha - Counsellor - K S Roy TB Hospital [HFW-27011/176/2024-MC Sec-dept of H&FW] and Regarding Approval of Leave of Priyanka Saha HFW-45035(16)/1/2024 CMOH S(24) Prgs	3.1: Ms. Priyanka Saha Counsellor - K S Roy TB applied for re-joining on 15-04-2024 to Superintendent KS Roy TB Hospital after unauthorised absence from 21-02-24 to 13-04-2024 without a fitness certificate. Superintendent KS Roy TB Hospital sent her to CMOH South 24 Parganas for rejoining provided she has submitted a fitness certificate. However, a file for unauthorised absence was initiated by CMOH, South 24 Parganas and placed before 23 rd HRAC for guidance regarding her rejoining after such long unauthorised absence. 3.2: Based on the same since the decision for her rejoining was communicated in the Resolution of 23 rd HRAC Meeting vide Memo No. HFW/NHM-466/2020/Pt II/1795 dated 19-06-2024 and since CMOH, South 24 Parganas has allowed her rejoining

Transfer prayer of Sipra Purkait Bhandari, CHA of Patharpratima block File No. HFW- 45017(99)/63/2024-CMOH(HFW)- Dept. of H&FW	 5.1: As per order vide Memo No. HFW/NHM-466/2020/Pt-1/356 dated 26-05-2022 the Clause 1.4 states that "Inter district transfers, where Appointing Authorities are different will not be allowed except for newly created health districts or newly formed revenue districts carved out of the existing administrative district". Moreover, as per order vide No. HSL(Misc)- 136(30)/07 dated Wednesday Oct' 2007 regarding engagement of erstwhile 2nd ANMs, it was mentioned that the "selected candidates shall have to be a resident of one of the villages comprising the sub centre area." 5.2: Considering both the above Clauses the transfer of Smt. Sipra Purkait Bhandari, CHA(R) of Patharpratima block to Diamond Harbour cannot be considered. 5.3: CMOH and Member Secretary, DH&FWS, DHHD is being directed to communicate the decision to the conserved employee.

Complaints received against Mr. Subir Saha, Executive Assistant, Thalassemia Control unit, BSMCH, Bankura (File No. HFW- 21099/66/2023-MC SEC-Dept. of H&FW)	7.1: Repeated complaints has been received regarding the unprofessional behaviour, lack of sincerity, entering data without approval of authority and long unauthorised absence of Mr. Subir Saha, Executive Assistant, Thalassemia Control Unit, BSMCH, Bankura from MSVP and CMOH Bankura, and the same is being viewed seriously by the committee. 7.2: Further it may be noted that such allegations attract provision of termination under Clause 11 of Order issued vide Memo No. SHFWS/ESTD/-578/2012/1135 dated 16/10/2023. 7.3: However, it has been decided by the committee to monitor his performance including attendance strictly for another 3 months. 7.4: On completion of 3 months, MSVP BSMCH will send a detailed report to this end regarding the performance of Mr. Subir Saha, Executive Assistant, Thalassemia Control Unit, for continuation of his service further. 7.5: CMOH, Bankura is being instructed to renew his contract for 3 month only w.e.f 01-07-2024. Further renewal will be decided after receipt of performance report from MSVP, BSMCH, Bankura.

Issues Related to Transfer of Contractual Employees under NHM, West Bengal vide Memo No. HFW/NHM-466/2020/Pt-1/356 dated 26-05-2022	8.1: In partial modification of the order vide Memon No. HFW/NHM- 466/2020/Pt-1/356 dated 26-05 2022 regarding Transfer Guidelines of Contractual Employees under NHM West Bengal, it was decided that any employee who has applied for transfer and has been transferred will not be eligible for further transfer for the next 3 years subject to renewal of his contract w.e.f the issuance of the transfer order. 8.2: However, the above mentioned criteria will not be eligible for further transfer order.
