E- TENDER NOTICE NO.-39/ NHM of 2024-2025 (Civil & Electrical work) for construction of new SSK under different Blocks of South 24 Pgs.

1. Chief Medical Officer of Health & Secretary District Health & Family Welfare Samity, South 24 Parganas at M.R Bangur Hospital, 2nd floor, Kolkata-33, South 24 Parganas, invites e-tender from the intending experienced bonafide eligible resourceful outsiders and working contractors/agencies having experience in relevant nature and magnitude of the constructional work mentioned as noted in ANNEXURE-I (enclosed).
2. The accepting authority does not bind him –self to accept the lowest bidder and reserves the right to reject any or all of tenders received, without assigning any reasons. He further reserves the right of splitting up any contract and distributing the same to more than one bidder.
 - a. This is an e-procurement tender and also a two bid tender. First bid should contain document of earnest money & technical documents (i.e. trade license, pan card, credential etc.)and second bid should contain the financial offer to be submitted online.
3. Contractors /agencies are requested to observe the required credential. If any agency found submitted bid for the specific serial with below credential or false credential or any false paper the earnest money will be forfeited and proper action will be taken by the TIA.
4. The intending bidders should submit tenders within specified time along with scanned copies of original documents(scan of Xerox copy of any documents is not allowed) –
 - a. Trade License (Civil)(valid for current period 2025-2026),
 - b. Trade License (Electrical)(valid for current period 2025-2026),
 - c. G.S .T Registration number with certificate of last return of March 2025,
 - d. P-Tax Registration and last-challan(2025-2026)
 - e. Pan Card.
 - f. I.T Return for Assessment years-2022-23, 2023-2024 & 2024-2025
 - g. Audited Balance Sheet & Profit & Loss A/c of Financial years 2021-22, 2022-23 & 2023-2024 with due certification of a CA firm containing Membership No. and UDIN.
 - h. Separate Agreement (Notarized) need to be executed by agency with Civil Engineer (B.Tech or Diploma) & one Electrical Engineer (B.Tech or Diploma), agreement should be signed by both the parties and submit the pass certificate of both the engineers along with their scanned copy of Pan or Aadhaar Card.
 - i. For building works value less than Rs.25 Crore and which are predominantly civil work in nature with electrical components less than 25% of the estimated amount put to tender, the Civil contractor may be allowed to submit an agreement in non-judicial stamp paper of requisite value with an electrical contractor for execution of the electrical components of the particular work.
 - j. Structure and Origination of the firm as per Annexure-V, Section-B, Form-II.
 - k. Project in progress & non-grounded (Only for the department inviting tender) as per Annexure-VI.
- a) **Credentials:** The bidders shall have satisfactory completed as a **prime agency** during the last 5 years at least one work of **Repair & Renovation/New Construction of Building** works which includes electrical works under the authority of State/Central Govt., State/Central Govt. under taking, Statutory bodies constituted under the statute of the Central/ State Govt. and having an amount of minimum percent (40%) of the estimated amount. No credential will be considered unless it is supported by Completion Certificate, payment certificate with relevant work order. (Completion certificate only signed by the GP Prodhan will not be accepted, it should be also signed by the GP Executive office).

- b) One bidder can apply for more than one bid subject to his credential being calculated on the sum total of all credentials of work done during 05 (five) years prior to the date of issue of e-tender.
N.B. Repair & Renovation/New Construction of Building works which includes electrical works is to be mentioned clearly with the quantity of works and amount. (Non-Statutory Documents)
- l. The Agency /Bidder /Firm/Company must arrange visit of their Civil and Electrical Engineer (at least one B.Tech or Diploma holder) during the execution of work and may be summoned for sharing necessary details if felt required by the tender inviting authority.
- m. In case of a partnership firm; it must be registered under any law.
- n. In case of a partnership firm/ co-operative institution there should be clearly mentioned the authorized person who carry on the business in favor of the institution in form of deed/agreement / resolution if applicable.
5. State Team & district team will make periodical onsite visit to review the progress of the work and check the quality of work being implemented.
6. The intending bidders shall have to furnish original certificates of all documents with execution of similar works of requisite magnitude as and when demanded by the tendering authority.
7. The Tender Inviting Committee has reserved the rights to accept/cancel any/all of the Tender at any phase of the process without further reference.

11. The bidder should quote his /their rates in figures and words on the basis of percentage above, below or at par with the schedule of rates attached with the tender form online.
12. A) As per Govt. Order No. 4608 – F(Y) Dated 18/07/18, to ensure the quality and prior execution of the work in public interest, the Governor is pleased to decide that Additional Performance Security @10% of the tendered amount shall be obtained from the successful bidder if the accepted bid value is 80% or less of the estimate put to tender.

B)The additional Performance Security shall be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his earnest money will be forfeited and other necessary actions as per NIT like blacklisting of the contractor, etc. may be taken. The

contractor, etc. may be taken. The Bank Guarantee shall have to be valid up to end of the Contract Period and shall be renewed accordingly, if required.

C) The Bank Guarantee shall be returned immediately on successful completion of the Contract. C) Performance Security will be deposited/deducted from bill at the prevailed rate as per the order of the Finance Department, Govt. of West Bengal vide its Memo No. 201-F(Y) dated 18.01.2021.
14. The successful bidder/s should execute an agreement with District Health & Family Welfare Samity, South 24 Parganas within ten days from the date of acceptance of the tender, failing which the tender be liable to be rejected.
15. Bidder /s shall be bound to execute any excess and supplementary works as may be ordered by the TIA at the rate of prevailing schedule of PWD/PW(R)D, GOVT. OF W.B at the time of tender submission.
16. Due to work at Hospital the Contractors/Agencies will be responsible for work at emergency basis and urgently finishing the work
17. All tools and plants and implements required for the construction of the work, will have to be supplied by the contractor at his/their own cost.
18. The applications of the bidder, who could not complete the works entrusted to them in past to the full satisfaction of this **District Health & Family Welfare Samity , South 24 Parganas** , will not be considered. Security Deposit, Labour Welfare Cess, T.D.S on Income Tax and G.S.T. will be deducted from the bills as per Govt. Rules. EMD/ Security Deposit will be released as per Govt. rules (vide memo.- 5696-F(Y), dtd.-01st October 2019 read with Memorandum Vide memo No. – 201- F(Y), dtd.- 18.01.2021) & Subject to fulfilment of the provision of clause 17 of WBF 2911 release of security Deposit after expiry of Defect Liability Period (DLP) shall be made as under as per G.O.- No. 5784-PW/L&A/2M-175/2017 dated 12.09.2017.

20. Any eligible bidder will be assigned job anywhere within the district as per the decision of Department/Tender Committee.
21. The Tender Committee reserves the rights to accept/cancel any/all of the tenders at any phase of the process without further reference. If in any Bid, more than 01 no. of LI bidder is found suitable after opening of financial bid, the decision of the Tender committee/ authority will be taken as per Finance Department order vide memo no. 2320-F(Y) dated-07.06.2022 for further decision if requires so.
22. The payment of the agency will be released after issuance of work-done satisfactory received from the concerned authority and certifying by the Engineering Cell.
23. State inspection team from Swasthya Bhawan will make periodical on site visits to review the progress of work and check the quality of work being implemented .no payments will be made until the clearance on the quality of the work has been permitted from higher authority.
24. All intended bidders are requested to keep close vigil on Website & on Office Board for any subsequent notice.
25. The Bidder shall provide an undertaking in from Affidavit (Given Below Annexure-II) in Non-Judicial Stamp Paper that the proprietor/ Promoter/ Director of the firm, its Employee, Partner or representative are not convicted by the court of law for offence involving moral turpitude in relation to business dealing such as bribery, corruption, fraud, substitution of bids, interpolation, misrepresentation evasion or habitual delay in payment of taxes etc. the firm does not employ a Govt.

Servant, who has been dismissed or removed on account of corruption. The firm has not been debarred, blacklisted by any Govt. Ministry/ Dept./ Local self Govt./PSU etc, in the last two years from the schedule date of Opening of this tender. The original Affidavit (Given below Annex-II) in Non-Judicial Stamp Paper will be submitted with the non-statutory documents in the below mentioned date.

26. Payment for the works will be made on availability of fund & subjected to fulfill of terms and condition. The payment is subject to due assessment and certification thereof by the Engineering unit, DPMU, South 24 Pgs (No payment will be made until the clearance on quality of the work has been permitted from the Engineering Section of DPMU). No interest will be paid in case of any late payment.
27. The successful contractor must complete the work within the stipulated time. No extension of time will be allowed except in special cases. If any contractor fails to complete the work within the stipulated time or termination of the contract before completion of the work, the work order will be cancelled without assigning any reason thereof. The excess expenditure if any due to such a step will be recovered from the unpaid bill/ Security deposits of the successful bidder. This is a part from any other penal measure the undersigned may take including blacklisting of contractors and forfeit of earnest money.
28. All works will have to be done according to specification and drawing approved by the authority and as per direction of the Engineer in charge. The mode of measurement will be according to rule of P.W.D. Govt. of West Bengal, as the work will be executed as per schedule of rates, specifications of P.W.D. There will be no price escalation in any reason.
29. Before issuing the work order authority may desire to check into all Original Documents.
30. Before submission of the tender, contractors must visit /inspect the work site at own cost to judge the local situation /condition, approachable road etc. No plea/complain about the site, approach road etc. shall be entertained afterwards. It shall be presumed that the agency offered the rate after taking into account the entire position of the work site.
31. Before issuance of the work order, the tender inviting authority may verify the credential & other documents of the lowest tendered if found necessary. After verification, if it is found that such documents submitted by the lowest tendered is either manufacturer or false in that case, work order will not be issued in favors of the tendered under any circumstances.
32. Validity of Tender will normally be 120 DAYS from the date of acceptance of tender.
33. Agencies have to arrange land for keeping Plant & Machineries, storing of materials labour shed, laboratory etc. water and electricity at their own cost and responsibility.
34. The authority reserves the right to issue any corrigendum to the NIT or reject the NIT in part or in full even the entire tender process at any time prior to the award of contract without assigning any reasons thereof.
35. After receiving the AOC, if the agency does not start the work within 30(thirty) days without valid reasons, then the respective work order may be cancelled and offer letter may be issued to the L2 bidder depending upon the decision of Tender selection committee.
36. Participating bidder's present progress of work from our department will be checked before issuing offer letter. If the progress is not satisfactory then his/her offer letter may be cancelled and the offer may be given to L2 bidder depending upon the decision of Tender selection committee.[Enclosed in Annexure-VI]
37. Special Terms and conditions pertaining to **KARMASHREE** Scheme. The Contractor/Agency should mandatorily fulfill the objective of the KARMASHREE Scheme by regulating rural unskilled workers, registered under MGNREGS through Job cards, eligible to get employment under the scheme as per the Kolkata Gazette Notification published on Thursday, March 7, 2024 vide No. 1140 PRD-33011/1/2024-MGNREGA SEC Dated 07.03.2024. The Contractor/Agency executing the work shall also furnish a certificate (Annexure-VII of the said Gazette Notification) after completion of the work that only Job card holders were engaged for unskilled works during execution. The certificate shall be countersigned by the departmental officials directly supervising the work. Scrutiny of such certificates will be done by departmental officials before making payment against the works.

38. Constructor's Equipment holding of plant and machinery as per [Annexure-VIII, Section-B, Form-IV] and in case of any agency not having this plant & machinery he or she can make agreement (Notarized) with any person having this plant and machinery and submit original tax invoice in both the cases.
39. Bank Solvency from any reputed Bank (Solvency should be minimum 40% of the total project undertaken in this NIT).
40. Awarding of AOC to the L1 bidder depends on the decision of the Tender Selection Committee.
41. Agency or Bidder should streamlining the document upload to the e-tender portal as per vide memo no.3904-F(Y) dated-10.11.2025.
42. If department requires then the agencies have to performs and submit the Cube-Test report of concrete mix.


